

Senior Open Campus Privileges for the Class of 2024

Senior Open Campus privileges at Gilford High School provide students in the Class of 2024 with an opportunity to exercise responsibility while enjoying the benefits of academic achievement. The proposal for Senior Open Campus was initiated by the Gilford High School Student Council in the spring of 1989, discussed and endorsed by the administration and then presented to the Gilford School Board.

Seniors entitled to this privilege may choose to exercise one of the following options during their study hall periods: sign-out at the office and leave campus, go to the library or cafeteria, or attend their assigned study hall. Seniors who have study hall assigned for the first block may report to school at the close of first block provided they sign-in at the Front Desk. This privilege does not entitle seniors to wander around the building or gather in the gym lobby area. Additionally, it is important for seniors to understand that schedule changes for the sole purpose of early release will not be endorsed.

Members of the Class of 2024 have, as established by the Gilford School Board in conjunction with the Gilford High School Administration and High School Student Council, Senior Open Campus privileges in accordance with the following conditions:

- 1. Attain a grade point average of 2.67 in the immediately preceding trimester or overall GPA. Student cannot have below a 2.67 for 2 trimesters in a row or this will result in loss of privilege.
- 2. Maintain a full load of regular classes (4)
- 3. Attain parent permission.
- 4. Sign in/out at front desk leaving name, time and destination on each Occurrence.
- 5. Participate in the Gilford High School Craft Fair (senior requirement).
- 6. Must have at least 12 hours of community service already attained by senior Year
- 7. Abide by policy JH, Attendance, Absenteeism, and Truancy.
- 8. Do not bring food or drinks back to the building. If you are going out to eat, eat it there! Senior privilege is not a food delivery system for the underclassmen. This rule also applies to the Cafeteria during lunch period.
- 9. Drive in a responsible manner while exiting and entering campus.
- 10. Do not loiter in or around the building.
- 11. Agree not to transport a senior who does not have Open Campus privileges or an underclassman during the school day without permission from the administration, in accordance with the rules governing Senior Open Campus as stated in the Student-Parent Handbook.

ATTENDANCE

Seniors with Open Campus privileges who have one unexcused absence may lose Open Campus privileges for the remainder of that trimester. Seniors who have lost credit for a one credit or one-half credit course due to attendance policy regulations may lose Open Campus privileges.

STUDENT OBLIGATIONS:

Seniors with Open Campus privileges should not have any outstanding debts, such as, but not limited to food service debts, books, library charges, or athletic uniforms.

EXCEPTIONS

Provisions to waive academic qualifier will be considered for seniors who feel they should be allowed Senior Open Campus privilege due to exceptional effort, good attendance as defined by the attendance policy, and exemplary school citizenship. The process for approval requires a request be presented, in writing, to the Principal.

TEMPORARY SUSPENSION OF PRIVILEGES

During inclement weather, or in the event the school must be evacuated for any reason, Open Campus privileges will be suspended as stated in the Student-Parent Handbook.

IN THE EVENT OF VIOLATION

In the event that a student violates the conditions of Senior Open Campus, the privilege may be rescinded permanently for some infractions, or up to forty-five (45) school days for others. A second violation may result in loss of privilege for the remainder of the school year.

Disciplinary action may range from warnings to suspension based on the severity and frequency of the behavior

Behavior that interferes with the learning climate or orderly operation of the school will not be tolerated. Classroom teachers will handle minor misbehaviors via warnings, detentions, student conferences, and/or parent contact. Misbehavior of a greater frequency or seriousness will result in a written referral to the Assistant Principal. Disciplinary action may range from warnings to suspension based on the severity and frequency of the behavior. Habitual offenders could face permanent removal from the classroom or be directed towards alternative learning arrangements, as determined by the educational team.

Credits Earned at Middle School

The awarding of credit for courses taken prior to a student's entry to Gilford High School (GHS) as a ninth grader is to provide more academic opportunities for students during their high school years. All GHS graduation requirements shall still apply.

Students may gain high school credit for high school math and modern language at Gilford & Gilmanton Middle School. Credit for these courses will be recorded as pass/fail on the high school transcript upon demonstration of course competencies.

It shall be the High School Principal or the High School Principal's designee who will decide the awarding of credit in accordance with the policy and the defined administrative procedures.

Students seeking to earn high school credit must go through an **alternative approved program**. ELO policy IHBH.

Academic Honesty and Integrity

ADOPTION/REVISION NOTES –

a. **ADOPTION NOTE** - The use of generative artificial intelligence ("AI") tools is ever-present and becoming more so. Obvious concerns exist that students use such tools in place of their own work to the detriment of the development of their own critical thinking, writing and other skills, not to mention as a means of cheating or otherwise gaining an unfair advantage. Nonetheless, NHSBA recommends against a complete ban on AI tools due not only to their ubiquity and the constantly evolving difficulty in managing a ban. Perhaps more importantly, an outright ban fails to recognize that properly used, AI is a powerful tool both for teachers and students. With this in mind, NHSBA revised Section B of the policy to include a paragraph specific to improper use of AI, as well as language in some of the other examples of prohibited conduct to include reference to AI. The new section, B.3 "Improper Use of Artificial Intelligence", however, also allows for use within parameters established by a particular instructor or by district or school rules. NHSBA encourages school administrators, IT directors and teachers to consider such parameters.

NHSBA revision notes, August 2023, revised Section B to include provisions concerning use of AI, also revised section B.6 (formerly B.5). **May 2022**, new policy prepared at the request of multiple NHSBA member boards.

- **A.** <u>Statement of Policy</u>. All students are expected to demonstrate academic integrity and honesty. Students are expected to put forth their best effort on tests and assignments. Students are expected to demonstrate respect towards their instructors and peers by encouraging and facilitating learning. Engaging in various forms of cheating or academic dishonesty does not permit students to realize the full extent of their educational experience or their full academic potential. These expectations are directly related to the Board's educational objectives for students to learn to be responsible for and accept the consequences of their behavior.
- **B.** <u>Prohibited Behavior</u>. In addition to any standards or rules established by individual classroom teachers, the following behaviors are in violation of the standards of academic integrity and honesty and are specifically prohibited:

- 1. Cheating. Cheating is any act of academic dishonesty, which includes such things as receiving or communicating information to another student during a test or other assessment; looking at another's test or assessment during the exam; using notes or obtaining information during a test or assessment when prohibited; obtaining information about the questions or answers for an assessment prior to the administration of the exam; or whatever else is deemed contrary to the rules of fairness with respect to school work or assessment, including special rules developed by the instructor of the course.
- 2. Improper Use of AI Tools. Improper use of artificial intelligence ("AI") tools (e.g., ChatGPT, Googe Bard, Harvey.AI, etc.) is use which is inconsistent with the purpose, spirit, or specific instructions for assigned school work or homework. Students may only use AI tools in accordance with the teacher's specific instructions or pre-existing class, school or District guidelines. When use is permitted, students must state their use of the AI tools and, where applicable, find a legitimate, independent source to cite information. Teachers will provide general instructions related to the acceptable use of AI tools, but students are expected to obtain clarification from the teacher if they are uncertain of whether and how AI tools may be used on any given assignment.
- 3. **Plagiarism.** Plagiarism is the representation of someone else's ideas or words as one's own without crediting the source. It is the use, whether by paraphrase or direct quotation, of the published or unpublished work of another without full and clear acknowledgment through proper citation format. Sources of work that must be cited or otherwise acknowledged in order to avoid plagiarism include, but are not limited to, books, articles, websites, work of classmates/others, and Al tools (such as ChatGPT, Google Bard, Harvey.Al, etc.). Teachers should provide clear instructions related to the applicable standards of attribution and citation for a given assignment, but students are expected to obtain clarification from the teacher if they are uncertain of the applicable standards.
- 4. **Academic Misrepresentation.** Academic misrepresentation occurs when a student has another student or individual substitute for the individual during the taking of a test or other assessments.
- 5. **Academic Collusion.** Academic collusion is the sharing of test or other assessment questions or answers with another student without the instructor's permission. Academic collusion includes copying another student's homework without the instructor's permission or allowing another student to copy one's work. It also includes group collaboration on individual assignments without the instructor's permission.
- 6. **Dishonesty in Papers or Other Academic Work.** Dishonesty in papers or other academic work occurs when one submits work prepared by a writing service, an Al tool, or any another person. All work submitted for a course must be the student's own original work unless the sources are cited, or are otherwise in compliance with the teacher's instructions, or school or District guidelines.
- 7. **Self-Plagiarism (Work Done for One Course and Submitted in Another).** Self-Plagiarism occurs when a student for a class refers to work previously submitted in another class in order to fulfill the academic requirements in that latter class. In some instances, instructors may allow a certain amount of work from a prior course to be repurposed;

students who wish to do this must seek express approval from the instructor in advance.

- 8. **Unfair academic advantage.** Unfair academic advantage occurs when a student acts in such a way as to prevent or hinder another student's performance with respect to an academic activity. Examples include: concealing, destroying, or stealing research or library materials with the purpose of depriving others of their use; sabotaging another student's work; or attempting intimidation for academic advantage.
- 9. **Facilitating academic dishonesty**. Facilitating academic dishonesty occurs when one student completes an academic activity (e.g., homework, test, paper, etc.) for another student, or collaborates with another student on an academic activity when instructions have called for independent work.
- 10. Other Academic Dishonesty. This policy also prohibits any intentional act that violates the spirit of academic integrity and this policy. Such prohibited conduct includes, but is not limited to, stealing assessments; tampering with academic records; including inaccurate academic information on any application or resume; altering academic tests or assessments, grades or other student records; distributing materials for the purpose of cheating or facilitating; inappropriate or unethical use of technology (pre-program of graphing calculator, smart phones, etc.); or feigning illness or personal circumstances to avoid an academic activity (e.g., test, quiz, paper, homework, lecture, etc.).

C. Consequences.

The disciplinary consequences for violations of this policy shall be consistent with Board policy and the Student/Parent Handbook. The minimum consequence will be a failing grade at teacher discretion and a conference with the student's parent/guardian. The Superintendent or designee shall list in the applicable Student/Parent Handbook, the specific range of additional consequences that may be imposed on a student for violations of this policy. For a high school student, violations of academic integrity and honesty are cumulative during the student's high school years.
